The beautiful bathing bay of Cala Llombards is also only about a 10-minute walk away – ideal for spontaneous trips to the sea. Other beaches such as Cala Santanyí, Cala Mondragó and S'Amarador are also in the immediate vicinity.

Thanks to the excellent connection to the Ma-19 motorway, Palma de Mallorca can also be reached in about 45-50 minutes.

The nearest golf course, Vall d'Or Golf, is only about 20 minutes away and offers one of the most beautiful sea views on the island.

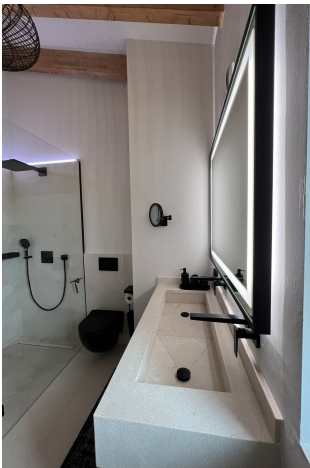
